OLD BUSINESS:

Park and Recreation Events: Ms. Smith informed the board that the Annual Easter Egg Hunt went great, was a little muddy but overall the event was great.

Fish Rodeo: Ms. Smith told the board that the Annual Fish Rodeo will be held on Saturday, May 5th at Sunnybrook Ballroom creek. She explained that they had 25 kids signed up and they can accept 50 kids to fish location. There will be free hot dogs and also prizes for the kids who attend. Gerald Richards Update: Ms. Smith updated the board on the progress of Gerald Richards Park updates. She informed them that infiltration testing was completed last week and they hit shale and water 11 feet down. Top soil might need to be added to the fields. Ms. Smith also told the board that they are adjusting the previous NPDES permit to reflect the new construction for Phase 2 of Gerald Richards so that both projects can be bid out together.
