Lower Pottsgrove Township Parks and Recreation Board Meeting Monday January 22, 2017

The regularly scheduled Parks and Recreation meeting was held Monday January 22, 2017 and was called to order at 7:01 PM. The following were in attendance:

A motion was made by Mr. Troutman to approve the November Minutes and was then seconded by Mr. Zlomek which was carried out with a 5-0 vote of approval.

OLD BUSINESS:

Predator Baseball: Ms. Smith informed the Board that in their packets there were two lease agreements examples from New Hanover that they used with a soccer club with one of their fields. Ms. Smith asked the board to decide where they stand with leasing the land at Pleasant View and Bliem to the Predators. After much discussion the motion was made by Mr. Zlomek to recommend to the Board of Commissioners that we do not want to pursue this offer at this time because we prefer the Township to control the Planning, Development, Construction, Maintenance and Scheduling of public owned recreational facilities. Which was then seconded by Mr. Troutman with a 5-0 vote of approval.

Gerald Richards Park Grants: Ms. Smith reviewed with the board the grants that the township has open right now. The PAHWF/DCNR mini grant that was awarded for 25,000 which is due 10/1/2018. DCED CDBG that was awarded for 82,450 which is due by 7/1/2019. Montco 2040 which was awarded for 80,000 with a due date of 8/31/2018. The final grant that the township has is DCNR C2P2 which the township was awarded 175,000 and the due date is 12/31/2021.
