



RESOLUTION 453-N

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF LOWER POTTS GROVE TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA AMENDING AND ESTABLISHING CERTAIN FEES, DEPOSITS, AND ESCROWS PAYABLE TO THE TOWNSHIP

WHEREAS, it is the desire of the Board of Commissioners of the Township to hereby amend and establish all fees and escrows currently set forth in the Code of Ordinances of the Township of Lower Pottsgrove as hereinafter referenced by this Resolution;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Commissioners of Lower Pottsgrove Township that all fees and escrows set forth in the Township Code of Ordinances are repealed and replaced with the following:

POLICE DEPARTMENT FEES

- A. Annual License Fee (Non-Refundable): \$150.00 per year for first employee and \$50.00 per year for each additional employee

CODE ENFORCEMENT FEES

A. New Construction

Permit fee shall be based on the International Code Council (ICC) Permit Fee Schedule, as published in the "Building Safety Journal" as published by (International Code Council) on a semi-annual basis. The Township shall use the most current Permit Fee Schedule. The method of permit calculations is based on modifying the building gross area, by the average cost per square foot, of the Type of Construction Factor for the specified Use Group/Type of Construction of the given project. It is then modified by the permit fee multiplier. The Table entitled "Type of Construction Factor" is a set of ratios that reflect the relative cost of construction for the Use Group/Type of Construction Combinations. The Use Group and Type of Construction are based on Table 503 of the 2009 International Building Code. The permit fee multiplier shall be .0085.

B. Use & Occupancy Permit Fees

A Use & Occupancy Permit fee shall be imposed for all Building Permits. Such fee will include one Use & Occupancy inspection. Fees for Use & Occupancy Permits shall be as follows:

a.	New Residential Unit (per housing unit)	\$80.00
b.	New Industrial/Commercial/Non-Residential	\$85.00
c.	Residential Addition/Renovation or similar use	\$25.00
d.	Residential Accessory Buildings/garages, barns, etc.	\$25.00
e.	Industrial/Commercial/Non-Residential renovation/ Alterations/tenant fit outs/change in use new ownership/ new tenant)	\$85.00
f.	Sheds for other Use Groups- Non-residential uses	\$85.00
g.	Special events/temporary uses as determined by Director of Code Enforcement (tent sales, job trailers, circus performances, carnivals, dances, etc.)	\$85.00

C. Additions and Alterations

Additions/alterations which can be measured in square feet shall take the same rate as for new construction. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus Use & Occupancy fee for the type use. Minimum charge for all other Use Groups shall be \$60.00 plus the Use & Occupancy for the type of use.

Alteration/renovations which can not be measured in square feet shall be calculated at a rate of two percent (2%) of the total cost of construction (including all labor, material and related costs). Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus Use & Occupancy fee. Minimum charge for all other Use Groups shall be \$60.00 plus the Use & Occupancy for the type of use.

D. Accessory Buildings, Basements, Garages, Decks, Porches, or other similar type construction

Accessory buildings or areas: such as garages, barns, or additions to accessory buildings, thereto which can be measured on a square foot basis, shall take the rate of type applicable construction costs. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus Use & Occupancy fee. Minimum charge for all other Use Groups shall be \$60.00 plus the Use & Occupancy for the type of use.

Decks/Porches which can be measured on a square footage basis shall be at one-half (1/2) the applicable construction costs. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus Use & Occupancy fee. Minimum charge for all other Use Groups shall be \$60.00 plus the Use & Occupancy for the type of use.

Accessory structures, lawn and garden sheds that are less than 225 square feet in size for One- and Two-Family Residential Use Groups shall require a zoning permit of \$30.00.

F. Demolition Permit

Demolition permits shall be charged on the basis of \$200.00 for the first 1,000 square feet and \$45.00 for each additional 500 square feet or any fraction thereof. Demolition Permits, which cannot be measured in square footage, shall be based on two percent (2%) of the total cost of demolition and removal.

G. Moving of Buildings

The fee for a Building Permit for the removal of a building or structure from one lot and placement of same on another lot or, at a new location on the same lot, shall be calculated at the rate of two percent (2%) of the total cost of moving, construction of new foundation and all work necessary to complete the building or structure.

H. Underground/Aboveground Storage Tanks

A Building permit is required for installation and a Demolition permit is required for removal.

Underground/Aboveground Storage Tanks: To install, remove, repair, or alter a tank used for the storage of flammable or combustible liquids or other liquids, or to modify or replace any line or dispensing device connected thereto. This includes non-combustible or non-flammable liquid storage tanks repairs and/or removal. The fees shall be two percent (2%) of the total costs of installation/removal/modification, this includes all related costs (labor, material, testing and related costs). Minimum fee shall be \$75.00 for One- and Two-Family Residential Dwelling Use Groups residential occupancy. A minimum of \$150.00 per tank for removal of all other use group occupancies will be charged.

All tank installations shall comply with all Federal, State and local requirements. Complete documentation relating to the removal/installation/modification/repair is required and shall include the following items but not limited to: Pennsylvania Department of Environmental Resources installers certification, letters of notification to Pennsylvania Department of Environmental Protection and Pennsylvania State Fire Marshal's Office for tank removal/installation, contractors insurance certificates and excavation sample test reports where required by the Fire Marshal or Code Administration Officer.

I. Miscellaneous Other Construction

Permit fees for construction, excluding signs, which cannot equitably be calculated on the basis of area, such as patio enclosures, silos, pools, water towers, canopies, railroad siding, alterations/renovations, roofs (non-residential uses), fencing (non-residential uses) tenant fit-outs and completion of unfinished spaces such as basements shall be calculated at a rate of two percent (2%) of the total cost of construction contemplated, including all material, labor, and associated costs. When free labor is used, the cost of such labor shall be estimated at market rates. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus Use & Occupancy fee. Minimum charge for all other Use Groups shall be \$60.00 plus the Use & Occupancy for the type of use.

Roof replacements for One- and Two-Family Residential Use Groups shall be a flat \$36.00 and no Use & Occupancy Permit fee is required.

Fencing shall be a flat \$30.00 zoning permit and no Use & Occupancy fee.

J. Sign Permits

Permits are required for all new and re-facing of any existing sign. All fees shall be calculated at the rate of two percent (2%) of total costs involved for material, labor, and associated costs. There is a \$100.00 application fee plus \$25.00 Use & Occupancy Permit for all Sign Permits. When free labor is used, the cost of such labor shall be estimated at market rates.

- Temporary signs (pennants, balloons, and off-premises signs) \$100 per sign
- Civic event signs (returnable deposit) \$100 per sign

K. Domestic Hot Water and Heating Solar Systems

Solar hot water heating system permit fees for One- and Two-Family Residential Dwelling Use Groups residential use heating shall be \$46.00.

Solar hot water heating system permit fees for commercial/non-residential/industrial use shall be \$116.00.

A Plumbing Permit may be required as determined by the Code Official.

L. Solid, Liquid, or Gaseous Fuel Burning Equipment

Fuel burning equipment permit fees shall be \$46.00.

M. Permits for Miscellaneous Construction

The fees for any permits not specified above shall be based upon an hourly rate for the time spent on the permit multiplied by two times the hourly rate of the inspector. The Use & Occupancy Permit shall be similarly calculated, however, shall be no less than the fee schedule of section 108.2. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus \$25.00 Use & Occupancy fee. Minimum charge for all other Use Groups shall be \$60.00 plus \$85.00 Use & Occupancy fee.

N. Failed Inspections, Occupying Space, or Performing Construction without Permits

In addition to any other fees paid to the Township, any failed inspection, which requires an additional inspection, shall result in an additional fee to be paid by the owner/or tenant/or permit applicant in an amount equal to the Use & Occupancy Permit fee.

Any inspection resulting in a determination that the owner/tenant/contractor/ occupant failed to obtain the required permits prior to construction or Use & Occupancy, Building, Plumbing, Fire Prevention, Demolition, Sign permits, etc., shall be charged a minimum surcharge of \$100.00 for One- and Two-Family Residential Dwelling Use Groups and a minimum of \$350.00 for all other use groups, in addition to the required fees for the permits required for the type of construction or Use & Occupancy Permit required.

O. Other Inspections

The fee for any other inspections performed by the Township staff shall be based upon the hourly rate for the inspector for the time spent multiplied by one and one half (1 ½) times the hourly rate of the inspector. Minimum charge for One- and Two-Family Residential Dwelling Use Groups shall be \$20.00 plus \$25.00 Use & Occupancy fee. Minimum charge for all other use groups shall be \$60.00 plus \$85.00 Use & Occupancy fee.

BUILDING PLAN REVIEW FEES

The Plan Review Fee shall be based on the cost of the construction. The fees are as follows:

Structural Plan Review Fee

All new buildings and modifications to existing buildings which the Township determines must be reviewed by third party structural engineer/consultant for compliance with structural requirements of all Township codes shall require that the applicant pay for all fees charged for such review. The structural review fee is on top of the basic plan review. All inspections for the structural requirements of the building code shall be special inspections and all related fees for inspections by third party structural engineer/consultant shall be paid for by the applicant.

Sprinkler Review Fee

The Sprinkler Review Fee is based on the number of sprinkler heads:

SUBDIVISION AND LAND DEVELOPMENT FEES

Permit and Application fees are non-refundable and cover Township administrative costs. Legal & Engineering Escrow amounts are intended to cover consulting fees incurred by the Township during the review process/inspection period and are not considered estimates of the cost of such services. Fees may vary based on the unique circumstances and complexities of individual applications. These fees are billed as set forth in this fee resolution. Failure to maintain a positive escrow balance will result in a stoppage of work and the addition of a late payment penalty on any balance unpaid after 30 days, as established by this fee resolution, until the escrow fund is replenished to a balance of a minimum 50% percent or greater. Applicants who do not have a positive balance in their escrow account at the time a bill is received for the project will be charged an administrative fee equal to 10% of the bill(s) received. Application fees and escrow fees should be submitted on two separate checks made out to Lower Pottsgrove Township.
