## LOWER POTTSGROVE TOWNSHIP AUTHORITY December 13, 2010

The Lower Pottsgrove Township Authority held their regularly scheduled meeting on Monday, December 13, 2010 meeting was called to order at 7:00 P.M. The following attended:

James Toth, Vice-Chairman David Richards, Treasurer Mark Loshnowsky, Secretary Rodney Hawthorne, Manager Howard Kalis, Solicitor William Dingman, Engineer

Gordon Walker was in and handed out a new finance analysis dated 12/13/10. We are now borrowing less money. We went from 4.9 million to 2.9 million overall refinance now is 12,010,000.00 and we pay off the Emmaus note. Our debt service will be less than the 1 million, a lower amount then we are paying now. The new payoff period will be for 20 years-total payout will be \$17,653,806.04 (Option C-1). Option C-1A numbers are even lower 2011debt service first payout is \$978,565.00. The Option C-1A is 17,396,420.00. The board did not take a motion but will vote in the future to approve the New Option C-1A.

**APPROVAL OF AUTHORITY MINUTES**: Mr. Mark Loshnowsky motioned to approve the minutes of November 8, 2010 and Mr. David Richards seconded the motion. All Approved.

#### **OLD BUSINESS:**

- 1. **Developers' Discussion & Update (CAP) and (CMP)---**Mr. Dingman reported on the CAP/CMP report #43 and the letter Mr. Hawthorne received from DEP. Mr. Dingman called Jen Fields at DEP and Ms. Fields told Mr. Dingman we only need to add the force main to the CAP report. We have a letter ready to go if the board approves. Motion approving the content of the letter in response to their letter dated November 10<sup>th</sup> from DEP and authorizing Mr. Hawthorne to sign was made by Mr. Richards and seconded by Mr. Loshnowsky. All approved.
- 2. **DEP Consent Order and Agreement ---**Mr. Dingman had nothing new to report.
- 3. **Approval of Pilot Program With The Borough of Pottstown---**Mr. Hawthorne presented the final Pilot Program agreement to the Authority. We have had several meetings with the Borough staff over the past several months. We now have a procedure that both municipalities agree on to begin our Pilot Program in January 2011. Both solicitors have also reviewed the agreement and it is ready to approve. Mr. Hawthorne recommended to the Authority Board to approve the new Pilot Program. A motion to approve the Pilot Program was made by Mr. Richards and seconded by Mr. Loshnowsky. All approved.
- 4. **Force Main Project Costs/ Construction Bid Approval**—Motion to approve the force main costs subject to Mr. Dingman, Mr. Kalis and Mr. Hawthorne's additional review and to award the bid to Bulldog Construction for 1,274,600 was made by Mr. Richards and seconded by Mr. Loshnowsky. All approved.
- 5. **Buchert Ridge Community Approval of 8 Edu's---** A request for an additional 8 Edu's for Phase 2 of Buchert Ridge Community was presented in the Bursich review letter dated 12/3/10. Our Authority engineer has reviewed and is recommending the Authority to approve 8 Edu's for Buchert Ridge Community Phase 2. A motion to approve the 8 Edu's was made by Mr. Loshnowsky and Mr. Richards seconded the motion. All approved.
