TOWNSHIP STAFF REPORT

Park Report

Mrs. Henderson stated that the Public Works Department has cut the brush along the trail at Shire Drive Park, cut the grass at all the parks, repaired a water leak in the bathrooms at Sanatoga Park, serviced the lawnmowers, removed the garage at the parks, reseeded the playground at Sanatoga Park, and stained the exist Sanatoga Park sign.

Update on the grant projects at Sanatoga & Ringing Rocks Parks

Mrs. Henderson stated that the sign for Sanatoga Park has been ordered. For the Ringing Rocks Park grant we were only granted \$10,000 for the sign and to pave the existing driveway. Our initial request was for \$15,000 and hope to apply for another grant to obtain the balance of the project.

Update on Summer Concert Series June 25th-August 6th

Mrs. Henderson stated that the concert series started on Sunday. The rainy weather had us cancel the first concert which is rescheduled for Sunday, August 13th. This year's performers will be Zydeco-a-Go-Go, Bill Koss Combo, Flamin Dick and the Hot Rods, Stephanie Grace, Carnaby Street and Pottsgrove Community Band.

Update on 2023 Community Days

Mrs. Henderson stated that she has been trying to contact food truck vendors for the upcoming Community which is scheduled for Saturday, September 9, 2023 11:30am -1:30pm. Mr. Van Brammer and Mr. Ward were able to give some suggestions for some food truck vendors to contact. The bounce house has been ordered and paid for. 150 pumpkins were ordered from Willcox Farms for this year. Home Depot will be doing their Home Depot kids workshop kits again this year.


