Staff Reports

Gerald Richards Park Phase II Project

Mr. Wagner explained on July 18, 2021, a Prebid meeting was held for the project. He explains there was 7 bidders and bids are due August 2, 2021, by 11am. He stated that there is approximately \$525,000 to be put towards that project. Mr. Wagner stated that the Commissioners are now able to use the American Rescue Funds through the Federal Government at Gerald Richards due to it being heavily used during the pandemic. Mr. Wagner explained that Montgomery County has extended the timeline to substantially complete the project until May 31, 2022.

Community Day - 10/16/21

Mr. Wagner confirmed that a specific date was set for Community Day, October 16, 2021. Mr. Wagner suggests that we cancel Community Day due to the rising cases of the Delta Variant.

Mr. Vanbramer suggests that Community Day stay on the schedule until further review at the September meeting. Mr. Orlando agreed with Mr. Vanbramer. Mr. Wagner stated that Ms. Orler will continue to plan this event with the Police Department and Vendors.

Old Business

Mr. Vanbramer states Mr. Coxe and Mr. Jackson were present last meeting and spoke of field usage. Mr. Coxe stated that the numbers for Little League have gone up this year. Mr. Vanbramer stated Little League had new personnel which he believed helped registration.
