Updates on Township Parks

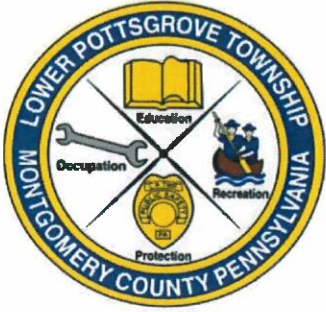
